Beyond the funds raised, these activities create awareness and bring new support to the Zajac Ranch for Children.

In order to ensure Independent fundraisers have a positive impact on the public image of Zajac Ranch for Children, the following policies must be followed:

1. The Zajac Ranch for Children logo is a registered trademark; unauthorized use is prohibited.
2. Official tax receipts will only be issued in accordance with the Canada Customs & Revenue Agency guidelines. The final decision to issue official tax receipts rests with Zajac Ranch for Children.
3. Whenever possible, Zajac Ranch for Children would appreciate written information or photographs which may be included in Zajac Ranch for Children publications and/or website
4. Zajac Ranch for Children **does not** participate in the following types of fundraising:

- Programs that involve a professional fundraiser and/or an agreement to raise funds on a commission, bonus or percentage basis.
- Events which promote the use of tobacco
- Vending machine sales
- Events involving promotion of political party, candidate or appearing to endorse a political activity.
- Directly soliciting funds door-to-door, through telemarketing, or through non-development internet methods.
